NGAC Appointment Status

- FGDC OS submitted a slate of 7 NGAC appointments to DOI in September.
 - Appointment letters are in DOI approval and signature process.
 - Once approved, NGAC will be at membership capacity (30).
- FGDC OS will submit a new slate of NGAC appointments in late winter after the Administration transition.
 - This slate will need to be vetted by the new Administration, timing TBD.
 - There are 9 NGAC members rolling off the committee as of March 7, 2025; 3 of which have re-applied.



TribalGIS Meeting Recap

- Tribal Geospatial Data Governance, Federal and Tribal Listening Session.
- Meeting October 23-24, 2024, draft briefing report in attendee review.
- Attendees Cross-discipline group of geospatial professional from Tribes and federal agencies to discuss Tribal geospatial data governance – 7 representatives from Tribes, 7 Federal agencies, FGDC OS.
- It is the recommendation of this group that a voting Tribal-Federal Data Governance Subcommittee of the FGDC be established, made up of both federal and Tribal representatives utilizing the Unfunded Mandates Reform Act (UMRA) exemption to FACA.
- Proposed make-up: 7 Tribal members, representing the 7 regions defined by the National Tribal Geographic Information Support Center; 6 members will represent Federal government entities.
