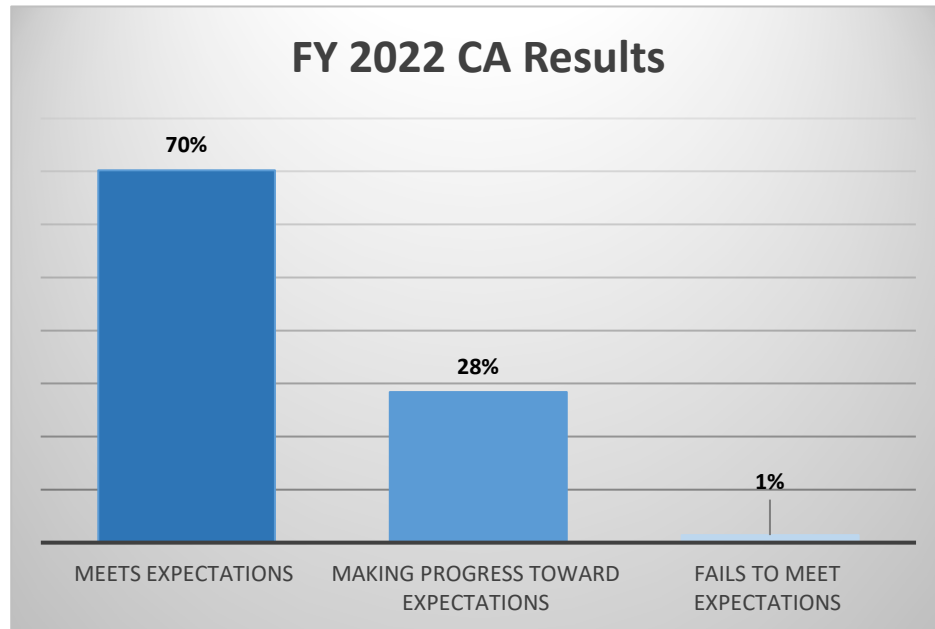

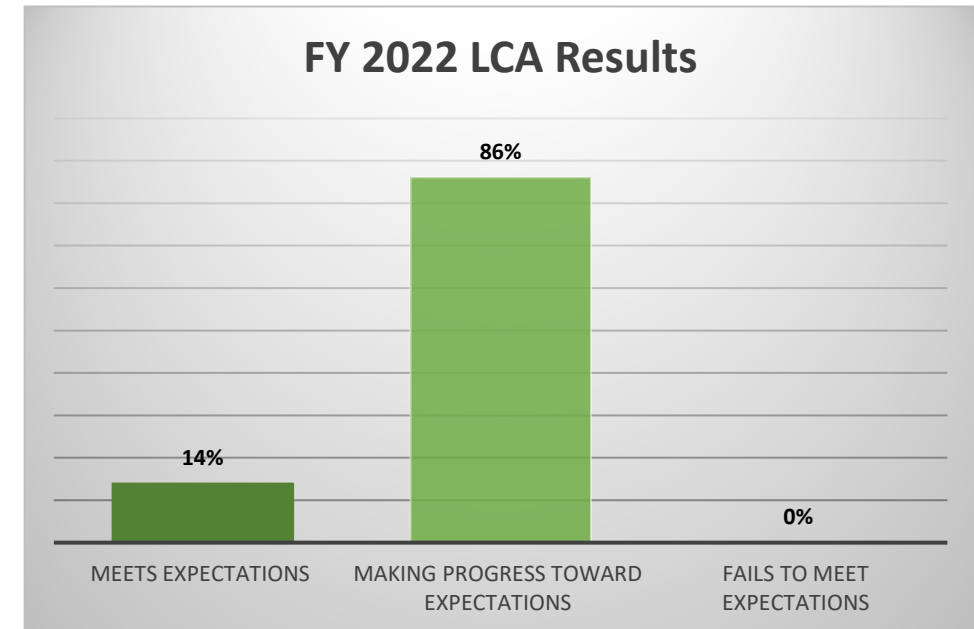
FY 2022 GDA reports

FY 2022 Covered Agency and Lead Covered Agency GDA annual reports and dashboards are posted to FGDC.gov



FY 2022 Covered Agency Results

Meets Expectations: 70% (146 of 208 requirements)
Made Progress Toward Expectations: 28% (59 of 208 requirements)
Fails to Meet Expectations: 2% (3 of 208 requirements)



FY 2022 Lead Covered Agency Results

Meets Expectations: 14% (10 of 72 requirements)
Made Progress Toward Expectations: 86% (62 of 72 requirements)
Fails to Meet Expectations: 0% (0 of 72 requirements)

NGDA Theme Strategic Plan

- Per the GDA, Lead Covered Agencies are required to draft an NGDA Theme Strategic Plan.
- Subgroup of the Theme Lead Community has been drafting a Theme Strategic Planning Template
 - Goals, objectives, and actions of the Strategic Plans have a one-to-one relationship with the mandates defined in Section 2805 of the GDA
 - Rigid enough to meet every requirement but;
 - Flexible enough to accommodate diverse approaches
- Target date for completion – December 2023

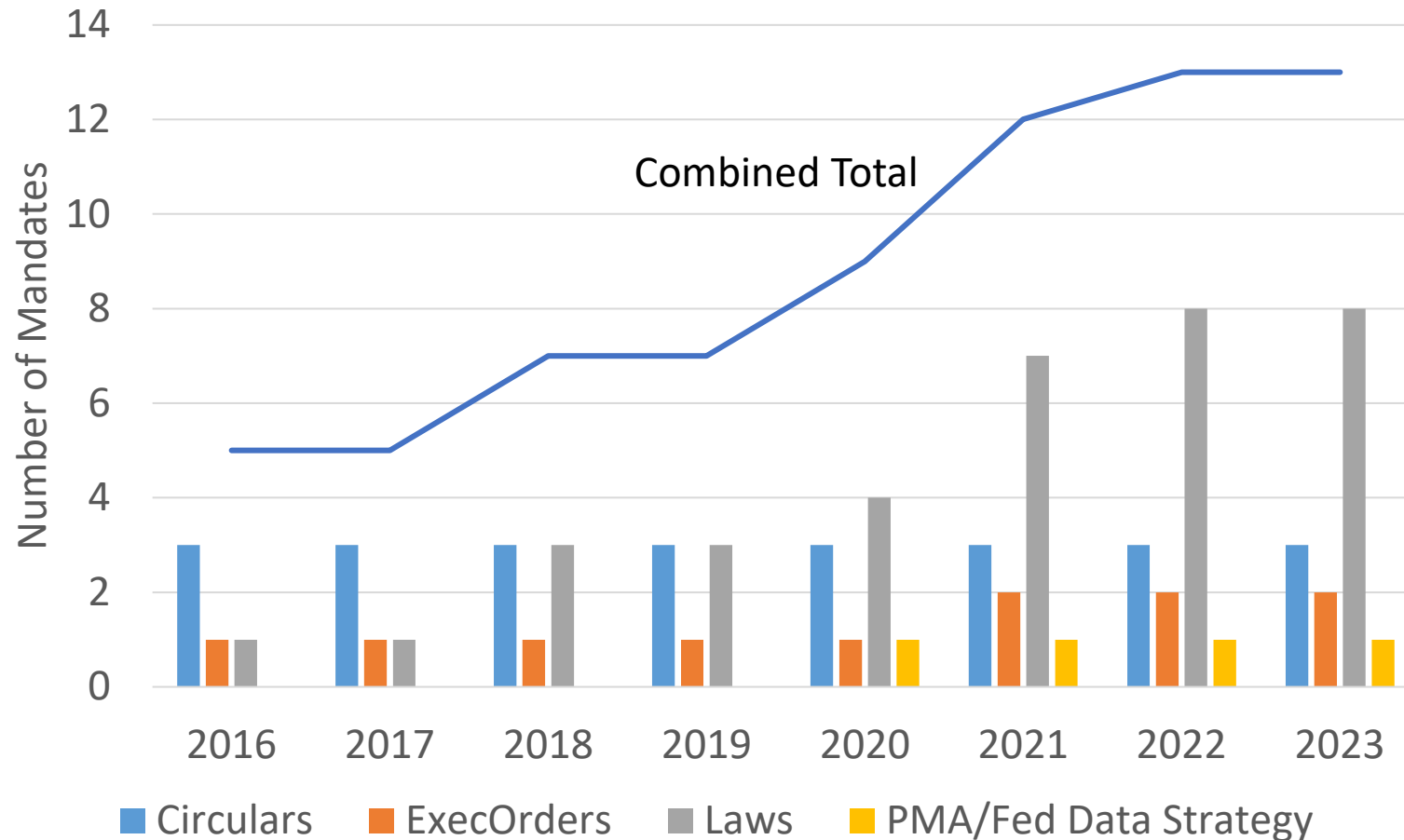

OMB Circular A-16 Revision

Objectives:

- The goals of the A-16 revision are to provide forward-looking guidance, incorporate and clarify GDA requirements, and to better align geospatial activities with the broader Federal data management enterprise.

Recent Activities:

- FGDC distributed draft version of Circular A-16 for FGDC/NGAC review and comment in October 2022.
- Over 350 comments received and adjudicated.
- Weekly meetings with OMB have taken place to review comments and finalize the draft.

Next Steps:

- Revised Circular A-16 undergoing review within OMB.
- OMB is planning a public review period for the revised draft Circular.

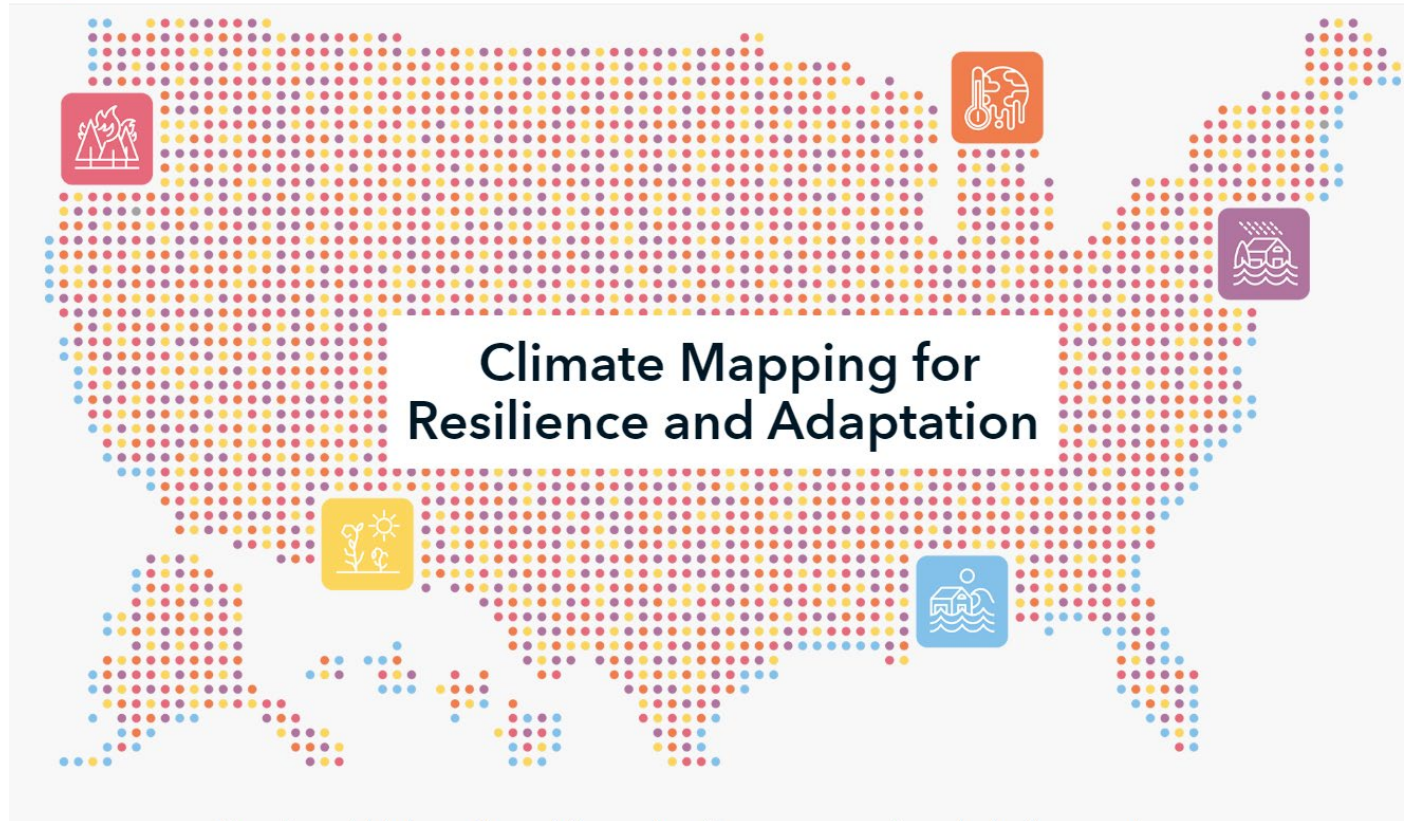
