Summary of Meeting: (Summarize the meeting, how many members in attendance, topics discussed, any input from members of the public, etc.)	The National Geospatial Advisory Committee (NGAC) held a public meeting on October 16-17, 2024, from 9:00 a.m. to 5:00 p.m. on October 16 th and from 9:00 a.m. to 4:00 p.m. on October 17 th . The meeting was held via webinar, teleconference, and in-person at the Department of Interior (DOI) Headquarters in Washington D.C. In accordance with the requirements of the Federal Advisory Committee Act, the meeting was open to the public. There were 21 NGAC members present, the DFO and alternate DFO, and 32 attendees.
	Agenda topics included a DOI Leadership discussion with Ms. Annalise Blum, on behalf of FGDC Chair Michael Brain, a review and status of NGAC recommendations and resolutions from 2008 to present, NGAC subcommittee report outs, presentations on the value of government data, Addresses presented by the Department of Transportation, and core Federal geospatial datasets from NGA and U.S. Census. There were also lightning talks from NGA and the Taylor Geospatial Institute. NGAC is also developing a multi-year roadmap which will include short and long-term goals. The following subcommittees gave updates on their work products: the Landsat Advisory Group, 3DEP, GDA, and the NSDI subcommittee.

	National Spatial Data Infrastructure (NSDI) Subcommittee ACTION: The subcommittee will continue its work on three main papers, with a potential fourth in the works. The goal across these papers is to improve information products, enhance data accessibility, and create efficiencies. Drafts of these papers are set for review in

The subcommittee aims to finalize drafts of the papers by December for review, with a goal of adoption by February. ACTION: Members will continue providing feedback on the quick wins and potential new initiatives to ensure that the subcommittee's efforts align with the broader goals of the NSDI and FGDC. NGAC Roadmap Session ACTION: Members will develop a one-to-two-page roadmap outlining immediate priorities. These include enhancing communication strategies, defining clear deliverables, and focusing on "quick wins" to demonstrate immediate impact. The roadmap will also include long-term strategies, with a focus on practical, achievable goals. A draft will be prepared and shared for review by December, with the aim of finalizing it by February. Smaller working groups will convene to refine ideas, synthesize feedback, and ensure that all sectors are represented in the final document. ACTION: Members will examine the feasibility of creating a compendium of use cases to illustrate the value of geospatial data to help make the case for continued investment and engagement.
