2014 GAO Engagement – Actions Status

GAO report released March 2015 (GAO-15-19), *Geospatial Data: Progress Needed* on Identifying Expenditures, Building and Utilizing a Data Infrastructure, and Reducing Duplicative Efforts

Four recommendations to FGDC

- Correct search function on Geospatial Platform and monitor regularly
 - Technical, and catalog record content improvements: on-going
- Regular collection of Geospatial Platform performance measures with reports to Steering Committee
 - Metrics and dashboards being designed and developed
- Create address data theme and associated subcommittees and working groups to further a national address database
 - Pilots being led by DOT and the Census Bureau continue
- NDOP to reassess the feasibility of the Imagery for the Nation initiative, identify discrete steps that could be taken to further a national imagery program for all levels of government
 - Initial assessment provided to SC and CG in September
 - ExCom reviewing and developing consensus on approach(es)




NGDA MP Completed Activities





FGDC Standards Activities

- United States Thoroughfare, Landmark, and Postal Address Data Standard (Address Data Standard)
 - Sean Uhl of Census briefed the CG on the Address Data Standard at its October 2015 meeting
 - A CG ballot to approve public review is being prepared

The SWG will meet next in early CY 2016 (TBD).

- SWG will discuss a proposal for mobile LIDAR standard (TBSL)
- Please submit standards documents to Julie Maitra at least 30 days in advance of the SWG meeting for review and consideration



FGDC Standards Activities

FGDC Standards WG charter (revised)

- CG ballot closed October 30
- Voting results: 6 yes, 0 no, 24 not voting.
- Agencies not voting were considered to have no substantive objections, and their votes were recorded as affirmative (yes) votes: therefore, 30 affirmative votes.
- NOAA voted to approve the charter, but provided comments worthy of additional discussion.



INCITS and OGC Activities

- INCITS L1/U.S TAG will meet November 20 to prepare for ISO TC 211 plenary and meetings scheduled for December 7-11 in Sydney, Australia. Agenda TBD.

OGC Standards Activities

- OGC and ASPRS to collaborate on geospatial standards
 - Standards for Point Cloud data are the first priority. The OGC Point Cloud Domain Working Group (DWG) has opened the DWG to OGC members and the public by allowing open membership to the email list and all meetings.
 - OGC and ASPRS will identify the scope of standards for other kinds of remotely sensed data, such as photogrammetric measurements and imagery data of various types.



GWG Standards Activities

- The 15-2 GWG voting session was held on October 21. Items of interest:
 - GeoPackage 1.0.1 FGDC has endorsed GeoPackage 1.0
 - Geopolitical Entities, Names and Codes (GENC) Standard 3.0 - FGDC has endorsed GENC Standard 2.0
 - OGC Web Processing Service (WPS) 2.0 FGDC has endorsed WPS 1.0.0
 - Web Map Tile Service (WMTS) Simple Profile 1.0
 - ISO 19146:2010, Geographic information Crossdomain vocabularies
 - OGC Table Joining Service (TJS) 1.0.0
