Welcome and Introductions, Ivan DeLoatch, FGDC OS

Ivan DeLoatch, FGDC Chair welcomed attendees to the meeting. Meeting participant introductions were made.

Previous Meeting Action Item Review, Lucia Foulkes, FGDC OS

Actions from September's meeting were reviewed.

FGDC Business Highlights, Ken Shaffer, FGDC OS

Ken Shaffer reported on FGDC business activities. Highlights included the following:

Annual Report

The theme for 2016 is "Recognizing Successes and Planning for the Future". The intent is to highlight our accomplishments for the new administration. Current focus on compiling content and graphics. The goal is to have a pdf version by mid-December and printed copies by January 2017.

Committee Decisions Summary

On September 29th, FGDC presented the first 2016 Doug D. Nebert NSDI Champion of the Year Award to the "Oak Ridge National Laboratory Distributed Active Archive Center" (ORNL DAAC) MODIS team. Suresh Kumar, Makhan Virdi, and Robert Cook received the award on behalf of the team. Doug Nebert's parents Myrna and Robert Bernstein were also in attendance. The award was presented by FGDC Chair Camille Touton, USGS AD for Core Science Systems Kevin Gallagher, and FGDC Executive Director Ivan DeLoatch.

The Steering Committee approved the Architecture and Technology Working Group charter, as well as the Standards Working Group Revised charter.

Steering Committee

The Steering Committee met on September 29th. This meeting was Camille Touton's last meeting as the FGDC chair. An acting chair will be designated until the new administration is in place. FGDC will work with the Executive Committee to provide leadership until appointments are made.

Executive Committee

The Executive Committee (ExCom) had a conference call to discuss the feedback summary about the NSDI Strategic Framework, and to obtain ExCom's reactions to the feedback received. Another ExCom meeting is scheduled on October 27th to discuss the annual report, transition strategy and other FGDC business items.

National Geospatial Advisory Committee (NGAC

The NGAC met on September 27 and 28 in Shepherdstown, WV. During the meeting, several NGAC members who completed their first term or second term were recognized for their service.

The NGAC subcommittees reported on the status of their assignments. They also discussed transition planning activities. Some of the key recommendations included:

- Emphasize how geospatial helps achieve Administration priorities
- Focus on support for effective decision-making
- Focus on value of outcomes to citizens
- Identify key messages
- Use analogies & use cases to demonstrate impact
- Focus on key program areas/priorities (jobs, homeland security, emergency response, health, etc.)

NGAC members also discussed the NSDI Strategic Framework and provided ideas and recommendations for consideration. Their feedback included the following:

- Consider re-envisioning or rebranding the NSDI
- Consider new organizational approaches for leadership of national geospatial programs
- Increase focus on users and consumers of geospatial information
- Focus on engagement with partners & stakeholders, not just outreach
- Continue progress on key initiatives

The NGAC meeting also included several lighting talks' sessions of interest to the geospatial community.

As a next step, the NGAC will develop a draft transition recommendation paper. The subcommittee will revise their draft paper based on NGAC feedback.

The text NGAC meeting will be held via webinar on December 14 (tentative date).

National Geospatial Data Asset (NGDA)

The NGDA Collaboration site has been released. This is internal site for NGDA managers. The 2015 Life Maturity Assessment Report will be completed in the fall. It was reported that the NGDA evaluation is close to completion. A draft report will be sent to Theme Leads and the Coordination Group.

The Steering Committee approved the establishment of the Address Theme. Theme Leads are being identified. FGDC is making sure the communication materials and website are updated.

Several Theme Strategic Plans have been completed, one is pending. The Theme Implementation Plan and Template was discussed during the Theme Lead meeting on October 5th. The next step is to complete the theme implementation plans and have final versions for the framework data themes by December 31st. The timeframe for completion of the other themes' implementation plans will be determined as part of the next NSDI strategic planning process.

The metadata guideline has been updated to include the Address Theme, and other editorial changes.

The NGDA inventory reported changes to Theme leads. Lynda Liptrap from the U.S. Census Bureau is the Theme Co-Lead for Address, and Deidre Bevington Attardi (U.S. Census Bureau) is the new Theme Lead for Governmental Units.

During the Theme Lead meeting Bob Pierce (USGS) proposed to remove the USGS National Structures Database. The issue is about having datasets that are not from the primary datasets developers/sources made available by another agency. The dataset will continue to be part of the NGDAs until further

discussion on how to address this type of scenario. There was also a discussion about adding the National Vegetation Classification as an NGDA Dataset.

Standards

The Standards Working Group met on September 27th. The meeting included discussions about FGDC endorsed standards, and briefings about the Common Framework for Earth Observations Data (CFEOD), the Semantic Web and the National Map, and the FGDC Architecture and Technology Group.

On September 20th, the CG approved the INCITS/ISO 19115-1:2014[2014], Geographic information - Metadata - Part 1: Fundamentals, and INCITS/ISO 19157:2013[2014], Geographic information - Data quality.

The Steering Committee voted on September 21st to endorse the Standards Working Group charter and the Architecture and Technology Working Group Charter.

The Open Geospatial Consortium (OGC) Technical Committee voted and approved the following:

- Update of the OGC Abstract Specification Topic 11: Metadata from ISO 19115:2003 to ISO 19115-1:2014
- CAT 3.0 Executable Test Suite

The OGC planning Committee voted to approve the update of OGC Abstract Specification Topic: Metadata.

ACTION: The FGDC Secretariat will post the October CG materials on the FGDC website.

Geodetic Control Subcommittee, Juliana Blackwell, NOAA

Juliana Blackwell reported on the Geodetic Control Subcommittee activities. Dr. Dan Roman is the new NGDA Theme Lead for Geodetic Control. Ms. Blackwell discussed the new Datums, and reported that the subcommittee is supporting outreach activities to disseminate and make information available.

Ms. Blackwell noted the following datasets within the theme and reported on their status.

- <u>AirBorne Gravity:</u> 50% of the data collection is complete. This data is what will be updating the current data that is coming up in 2022. Gravity data information was collected from aircraft and unmanned aerial systems to reach out to remote places.
- Continuously Operating Reference Station (CORS): NGS captured over 1800 sites and performed
 quality control of the collected data and made it available to the public. Data from CORS network
 are utilized by U.S. citizens for positioning throughout the country. It is also used for control
 point of land survey for ships and aircrafts.
- <u>Geoid Model</u>: The dataset has been available since 1990 and used by GPS and other technology to calculate heights based on the North American Vertical Datum of 1988. NGS is creating geoid models with refined gravity information to get more accurate information from GPS equipment.
- <u>Passive Marks</u>: These markers are the ones seen on the ground. The data will continue to be available. Through this database users can perform assessments on how the land has changed over time.

Recent subcommittee activities included following:

- The NGDA Strategic Plans for datasets was completed in June.
- NGS hosted a five day Airborne Garimetry for Geoidesy Summer School in May
- NOAA navigation services offices met with Cuba to identity priority activities for cooperation in hydrolatry and geodesy.

• NGS is planning the 2017 Geospatial Summit on April 24-25.

Geospatial Platform PMO Activities Update, Jim Irvine, ArdentMC

Ken Shaffer (FGDC) reported on the Geospatial Platform PMO support activities.

FGDC and GeoPlatform.gov are offering cloud hosting services to member agencies. More information is available at https://www.geoplatform.gov/hosting

The Geospatial Platform's newest release (Release 6) included the following capabilities:

- CMS Core Bundle for new communities
- Enhanced Geospatial Search Tool; a new reusable GeoPlatform service for searching Data.gov Catalog
- Service Dashboard with enhanced service performance statistics
- O&M System Dashboard for improved O&M
- Metadata Editor design & model refinement
- GeoCONOPS and NCC community enhancements

In addition to these new capabilities, the team worked to further develope several communities within geoplatform.gov including the DHS GeoCONOPs, NGDA Collaboration Community (NCC), DHS GIRA Community, US Fisheries Program, NDOP Private Community Support, 3DEP Working Group, and the National Address Standards Wiki.

The Architecture and Technology Working Group (ATWG) supports the geospatial platform activities. In their last meeting there were discussions about refining feedback procedures, new requirements, and marketing opportunities.

On December 7-8 there will be a GeoPlatform Workshop in the South Interior Auditorium. The workshop is sponsored by the GeoPlatform Managing Partner in conjunction with FGDC and NGA. The purpose of the workshop is to present the Geospatial Platform implementation and share GeoPlatform.gov functional capabilities to data stewards.

ACTION: The FGDC Secretariat will forward the information about the Geospatial Platform workshop to theme leads and dataset managers.

<u>Artic Spatial Data Infrastructure (SDI), Lorna Schmid, USGS, U.S. National Contact Point</u>
Lorna Schmid spoke about the Artic Council and discussed the Artic Spatial Data Infrastructure (SDI).

The Artic Council is chaired by the US. Secretary of State. The main focus is climate change and its condition. The Artic Council has 6 working groups and it covers a wide range of areas. In 2014 a Memorandum of Understanding (MOU) was signed between the Arctic countries to develop an Arctic Spatial Data Infrastructure (SDI). A Geoportal was launched and a governance model, including a 5-year strategic plan was established.

Ms. Schmid discussed the development process of the Arctic SDI Pilot. The outcome of the pilot will be presented in a scenario based video to demonstrate the value of having data available for emergency preparedness and decision making in the Arctic. The pilot will be helping not just the Arctic but also everyone working with spatial data. The pilot will be taking an agile development approach.

Ms. Schmid provided a video demo about the Arctic SDI geoportal. The video can be accessed here https://www.youtube.com/watch?v=VtlTedwelAk

NSDI Strategic Framework, John Mahoney, FGDC OS

John Mahoney discussed the NSDI Strategic planning process and reported that the NGAC provided suggestions for consideration in the next version of the NSDI Strategic Plan. Some of the comments included:

- Revisit the policy framework
- Outreach and engage with federal and local, state, private sector, academia
- Develop key messages to convey the value of the NSDI inside the government and outside the government
- Rebrand the NSDI, and focus the messaging.

CG members were encouraged to share their ideas and suggestions about opportunities they would like to see included in the new version of the NSDI Strategic Plan.
