Committee's Decisions Summary

- On December 16, the FGDC Steering Committee approved the <u>National Spatial Data Infrastructure (NSDI) Strategic</u> <u>Framework</u> document.
 - Describes a broad national approach for the continued sustainable development of the NSDI.
 - Includes goals and objectives for the Federal government's role and also includes strategies and possible actions for the greater geospatial community to work collaboratively on broader national issues.
 - The final draft framework addresses comments received through the comment period and through the most recent meetings with the FGDC Steering Committee, the NGAC, and the Leaders Forum. The NSDI Core Team has adjudicated the comments and made updates and changes to the plan where appropriate. Committee's Decision Summary

- The <u>FGDC Recommendations for the 2017 Transition</u> paper was approved on December 9th. This document is written from a federal perspective and is intended for use by the DOI and other FGDC agencies to inform the incoming Administration of its importance, opportunities, and broad support across the community. The document is being limited to one-page (front and back).
- The <u>Department of Homeland Security (DHS) Geospatial</u> <u>Information Infrastructure (GII)</u> paper was developed to emphasize the federated relationship between the Geospatial Platform (public) and DHS GII (sensitive but unclassified) platform.

2014 GAO Engagement – Actions Status

2015 GAO report FGDC actions (3 remaining)

Create address data theme and associated subcommittees and working groups to further a national address database

Status: GAO has indicated that they be able to close this action upon publication of the Address Theme description to the FGDC website.

- Pending action review of GAO's annual status update on all actions determined to deal with duplication and potential cost savings. FGDC OS coordinated responses to questions:
 - USGS: Status of Water preparing closure package
 - DOT/DOC: Status of actions supporting the new Address NGDA Theme
 - OMB/FGDC OS: Information on how the NGDA Theme implementation plans support investment reporting, and how to locate "planned" investment records from agencies on the GeoPlatform Marketplace




- Restarting web services and metadata project
 - Data.gov completed migration late January
 - Harvesting has restarted with existing sources
 - Federal and non-Federal metadata publishers are required to have an OMB MAX account - see overview <u>https://www.data.gov/meta/data-gov-infrastructure-migration-notice-federal-non-federal-users/</u>
 - Instructions for how to get an account and login into Data.gov to manage harvest sources posted at <u>https://cms.geoplatform.gov/resources</u>
 - Coordinate with NGDA Dataset Managers and Theme Leads to work towards an end of March completion for updating metadata records with web services and download links and publishing to Data.gov/Geoplatform.gov

- Theme Implementation Plans Status
 - Updated template available with some editorial and reporting changes identified during 1/5 Theme Lead Meeting <u>https://cms.geoplatform.gov/A-16-NGDA-Theme-Community</u>
 - Framework Themes due in February and all Themes are required to report by 4/28/17 (for Oct. 2016-Mar. 2017 reporting period)
- Theme Strategic Plan Update
 - Template updated to include guidance for Themes to revise their Theme Strategic Plan on an annual basis if needed
 - Will allow for Theme Strategic Plan and Implementation Plan to be aligned across 5-year timeframe <u>https://cms.geoplatform.gov/A-16-NGDA-Theme-Community</u>



NGDA Portfolio Summary Report

- Aggregates information across all Themes
- Initial draft completed in 2016
- Will be looking at additional information from "2015 Lifecycle Maturity Assessment Analysis and Recommendation Report", Theme Strategic Plans and Implementation Plans
- Distribute for review to Theme Leads and CG members





- 2017 Lifecycle Maturity Assessment
 - Completed Administrative and General Questions
 - Working on Stage 1 Define/Plan (e.g., business requirements process, stakeholder engagement, quality assurance process, etc.)
 - Beginning on Stage 2 Inventory/Evaluate (e.g., list of data assets and data gaps (both internal and external) as they relate to business-driven user needs)
 - Developing business requirements for technical implementation
 - Anticipate LMA release in May 2017 with all NGDA assessments complete by Dataset Managers by mid-August 2017

- The FGDC Standards Coordinator is preparing a consolidated directory of FGDC-endorsed standards and other significant standardsrelated documents.
- Also reviewing historical standards documents (hardcopy) for disposition.



Standards tracking

 The standards tracking workbook covers over 300 standards from FGDC, INCITS Technical Committee L1, ISO Technical Committee 211, OGC, and other standardization activities.
The effort is very time-intensive, due to the amount of information collected, reviewed, and corroborated.


